1. I, the undersigned (“**Author**”) (**a**) agrees to participate in the **World Orchid Conference 2026 (“WOC 2026”)**, hosted by the German Orchid Society (“**D.O.G.**”) in cooperation with the **World Orchid Conference Trust (“Trust”)** and (**b**) authorizes the D.O.G. and the Trust to record and re-record my likeness, presentation materials, and voice, which may be edited and adapted as deemed appropriate for non-profit production, including without limitation, use any and all still images, video, and audio for broadcast news, advertising, marketing, public relations, simultaneous AI based translation, internet, intranet and/or other promotional purposes worldwide before, during and after the conference. The presentations will not be published in full length without prior written consent by the respective speakers.

2. Author expressly releases the D.O.G., the Trust, and their respective licensees and assignees, from any and all claims, demands or liabilities related to my/our participation in the WOC 2026 and authorizes the use of my name, likeness, voice, biography, video and article for all program information, promotion of the **2026 World Orchid Conference**, the **D.O.G.**, the Trust, and all related purposes.

3. Author *and* all other co-authors warrant that the Article is his/her/their original work, and he/she/they have the right to grant this non-exclusive license (without infringing the rights of any third party, including photographs, botanical art and other graphics by non-authors) to the Publisher and the Trust. 4. If the D.O.G., also known as the "Publisher", accepts the Article, the Author and all co-authors grant a non-exclusive license to the Publisher and the Trust (this "Agreement") to:

a) For poster presentations:

1. The poster file must be transmitted to the D.O.G. before January 31th, 2026 for printing and posting.

b) For all presentations:

1. The full Article must be submitted to the D.O.G. before December 31th, 2025 for potential publication in the Proceedings at D.O.G.'s discretion.
2. All electronic files for the presentation at the WOC 2026 must be submitted to D.O.G. before January 31th, 2026. This includes all files, Power Point presentations, and pictures that will be used during the presentation
3. These files will be purged after the Proceedings is published.
4. The digital Proceedings may be placed on the D.O.G. and Trust websites sometime after they have been published.
